Additional information is needed to process the renewal of your license. As we discussed on the phone, June 5, 2012 the information is described below:

- Please confirm that you are requesting the removal of all 35.300 activities, including diagnostic and therapeutic uses of I-131. Accordingly, all references to 35.300 authorizations will be removed for your Authorized Users.
- Please confirm that you no longer wish to have the following Authorized Users listed on your license:
 - Robert D. Johnson, M.D.
 - Frederick Crowley, M.D.
 - Mark D. S. Wellens, M.D.
 - Ed Ray Smith, M. D.
 - Daniel Fodor, M.D.
- Your facility diagrams did not include what occupies the locations above and below your hot lab. Please provide this information.
- The mailing address on your current license does not include the reference to 1315 Hospital Drive. Please confirm that this additional information is requested in the mailing address. In addition, "Inc." is listed in your name on your current license. Please confirm if this should be included in the name, and if not, confirm that no changes to the ownership of the hospital have occurred.
- To assist in future communications, please provide business fax numbers and email addresses for Paul Bengtson and Bradley Collette, if they are available.
- Please provide a copy of the close out survey of the previously used locations for Nuclear Medicine referenced in your March 25, 2008 letter. Also indicate if you released the location for unrestricted use and when it was released.
- Please note that detailed procedures were not required to be submitted in support of your application (e.g., spilled gas clearance time, area surveys, etc.) and were not reviewed. Radiation Safety procedures will be reviewed during future inspections.

Once we receive the additional information requested, we will continue our review of your license renewal. If we do not receive a reply from you within 30 calendar days from the date of this e-mail, we will assume that you do not wish to pursue your renewal. Please have your communication signed by Mr. Bengtson and respond to my attention, in writing, by letter or fax (610) 337-5269
