Hi Rob and Lisa

I will be out of the office starting on Thursday 8/4 and I will be back in the office on Monday 8/15. I forwarded you the contact list I sent you before. John Hufnagel is my back-up Licensing lead.

A few items for you to consider:

1. We (Exelon) have the capability to provide a document portal that would allow you to review documents ahead of time. I am exploring the idea of using it for the Limerick project. I understand that the STARS plants have done this for a few of their projects. I had enquired about this for the TMI-1 project (although we opted not to use it) and I have attached the NRC response for your reference. Our Portal meets all of the requirements outlined in the letter. If you're amenable to this process then would I need to notify you in writing formally or otherwise do something else?
2. Based on the preliminary schedule. Scoping and Screening methodology will be on us fairly quickly. I assume that Billy Rogers is leading the audit? Anyway, will he have the audit plan (including the systems that would require walk-downs) to me by early September? This is extremely helpful in lining up resources on our end to efficiently meet your needs.
3. There is a strong possibility that our TLAA engineer may be away October 6-18. I assume the TLAA review will be done on the second week of the AMP audit. It is ok because we have a back-up. However, if it was possible to move the TLAA portion of the audit to the first week (October 3rd) that would be very helpful in that our primary TLAA engineer would be available for the first three days.

Dear Mr. Gallagher:

By letter dated January 8, 2008, AmerGen Energy Company, LLC (AmerGen) submitted an application pursuant to 10 CFR Part 54 to renew the operating license for the Three Mile Island Nuclear Station, Unit 1 (TMI-1), for review by the U.S. Nuclear Regulatory Commission (NRC or the staff). On March 14, 2008, the NRC published a *Federal Register* notice of acceptance for docketing of the application and notice of opportunity for hearing for the TMI-1 license renewal.

To improve the efficiency of the license renewal review, AmerGen and NRC discussed the use of an online reference portal that would allow NRC staff limited read-only access to the applicant's basis documents and other reference material cited in the TMI-1 license renewal application. The online reference portal would allow staff to view basis documents to determine whether they are necessary for development of the Safety Evaluation Report (SER) or the Supplemental Environmental Impact Statement (SEIS). If the staff needs to rely on information from documents available on the online reference portal, the document must be formally requested and put on the license renewal docket. Use of the reference portal is acceptable as long as the following conditions are met by AmerGen and the NRC:

The online reference portal will be password-protected, and passwords will be distributed to staff directly involved in the license renewal review on a need-to-know basis;

The online reference portal will disable any printing, saving, or downloading functions;

The online reference portal will be sufficiently secure to prevent staff from printing, saving, or downloading any documents;

Staff given password access to the online reference portal will be informed of the conditions of use of the online reference portal by NRC project managers; and

Basis documents viewed from the online reference portal and subsequently used by the staff to develop the SER or the SEIS must be formally requested and submitted to the license renewal docket, thus making those documents publicly available.


The conditions associated with the online reference portal must be maintained throughout the duration of the TMI-1 license renewal review process. Please provide written confirmation of AmerGen agreeing to the terms and conditions contained in this letter.
