On May 17, 2012, from 6:00 pm to 9:00 pm, the U.S. Nuclear Regulatory Commission (NRC) met with members of the public at the Double Tree Hotel, Tarrytown, New York to discuss the NRC's assessment of safety performance at Indian Point for calendar year 2011.

From 6:00 pm to 8:00 pm the NRC held an Open House during which NRC personnel were available, in an informal setting, to answer questions from individuals and discuss issues or concerns related to Indian Point. From 7:00 pm to 9:00 pm the NRC hosted a question and answer session in an adjacent area, during which members of the public were able to ask questions or make statements in a public forum. The NRC did not make a formal presentation during the public meeting.

Public attendance was estimated to be approximately 350 and included representatives of federal, state, and local governments. Not everyone in attendance signed in or requested time to speak. Approximately 83 individuals requested time to make a statement or ask questions. Of the 83 individuals requesting time to speak, 52 made statements or asked questions. The remaining 31 individuals did not get the opportunity to speak due to time constraints. The NRC staff remained afterward to speak with stakeholders individually who did not have an opportunity to speak during the meeting. Most people who spoke made statements against the continued operation of Indian Point Units 2 and 3.
