SUBJECT: SUMMARY OF THE MAY 23, 2012 PUBLIC MEETING TO  
DISCUSS THE ADVANCE NOTICE OF PROPOSED  
RULEMAKING IMPLEMENTING NEAR-TERM TASK  
FORCE RECOMMENDATION 8, STRENGTHENING AND  
INTEGRATION OF ONSITE EMERGENCY RESPONSE  
CAPABILITIES RELATED TO THE FUKUSHIMA DAI-ICHI  
NUCLEAR POWER PLANT ACCIDENT

The Nuclear Regulatory Commission (NRC) held a Category 3 public meeting on May 23, 2012, to afford external stakeholders an opportunity to ask the NRC staff clarifying and amplifying questions on the advance notice of proposed rulemaking (ANPR), published in the *Federal Register* on April 18, 2012 (77 FR 23161), on Near-Term Task Force (NTTF) Recommendation 8, strengthening and integration of onsite emergency response capabilities such as emergency operating procedures, severe accident management guidelines, and the extensive damage mitigation guidelines. Details can be found in the *Near-Term Task Force Recommendations for Enhancing Reactor Safety in the 21<sup>st</sup> Century Report*, issued July 12, 2011, (Agencywide Documents Access and Management System (ADAMS) Accession No. ML111861807).

The meeting was held at NRC Headquarters in Rockville, Maryland, and it was attended by 14 people. Additional individuals remotely participated in the meeting through webinar and audio teleconferencing. The attendee list is provided as Enclosure 1. Since the NRC was not accepting public comments at the meeting, a transcript of the meeting was not obtained.

The notice and agenda for the meeting can be found in the NRC ADAMS under Accession No. ML12117A448. The NRC staff provided a presentation that led the discussion concerning the ANPR. The slides for the presentation are provided as Enclosure 2.
