The purpose of this letter is to notify you of completion of activities at a temporary jobsite under this license.

The work conducted at the former Lowry Training Annex in Colorado has been completed. The former Lowry Training Annex is located at:

3101 South Watkins Road
Watkins, Colorado 80137

Tetra Tech EC, Inc. (TtEC) had been contracted by the Department of the Navy to perform a confirmatory radiological survey to ensure that no depleted uranium (DU) munitions remain at former DU munition testing sites within the Lowry Training Annex. TtEC recovered a small number of DU fragments, radium contaminated objects, DU contaminated soil and radium contaminated soil, and maintained control of the materials as Low Level Radioactive Waste (LLRW) pending transfer to the Department of the Navy for disposal as LLRW.


The LLRW was transferred to the Navy's LLRW contractor, Hidden Waters, Inc. on May 3, 2012 for disposal at Clean Harbors Deer Trail, US Ecology-Idaho, Grand View, and Environmental Management and Controls, Turlock, California based on the LLRW components in the waste drums and the waste acceptance criteria of the respective facilities.
