3) Transportation and Route Schedule

The vessel is scheduled to sail from Walvis Bay, Namibia on March 12, 2012. The ocean transportation from Walvis Bay, Namibia to Montreal, Quebec, Canada will be the responsibility of CSA Line. The vessel will unload at Montreal, Quebec, Canada on or about March 31, 2012. The container will enter the USA by road at Champlain, NY between approx. April 8-20, 2012 and continue on to Metropolis, IL. The inland transportation from Montreal, PQ to Metropolis, IL will be the responsibility of RSB Logistic Services Inc.
