SUBJECT: SUMMARY OF MEETING TO DISCUSS APPLICANT'S APPROACH
FOR RESPONDING TO REQUEST FOR ADDITIONAL INFORMATION
RELATED TO FUKUSHIMA RECOMMENDATION 2.1 FOR THE
FERMI 3 COMBINED LICENSE APPLICATION

On Thursday, June 14, 2012, the U.S. Nuclear Regulatory Commission's (NRC) staff held a public meeting with members of Detroit Edison. The purpose of the conference call was to discuss the status of the applicant's response to a Request for Additional Information (RAI) related to Fukushima Recommendation 2.1. The slides utilized by the Fermi staff are attached Agencywide Documents Access and Management System (ADAMS) Accession No. ML12166A349. A copy of the attendance sheet ADAMS Accession No. ML121710084 is attached. Additionally, the following persons participated via the bridgeline: Michael Keegan, Don't Waste Michigan; Maria Jaworsky, Duke Entergy; David Robillard, Public Service Electric and Gas; Bob Young, Black and Veach; Manuel Miranda, Brookhaven National Laboratory.

During the presentation the staff asked the applicant for a date when a draft of the RAI response would be available for review. The applicant stated that preliminary results and a presentation of the draft RAI response would be available at the end of July 2012. The status of this action will be tracked during the weekly open items calls with the applicant.

During the public comment and question portion of the meeting Mr. Michael Keegan of Don't Waste Michigan, asked if the Bowling Green Fault was being considered in the RAI response. The staff will research, prepare, and e-mail a response to Mr. Keegan's question.
