Dear Dr. Durbin:

Enclosed is Amendment No. 60 to your NRC Material License No. 24-08960-02. This amendment is issued in accordance with your request, **with the exception of the request to add Bradley W. Stockmann, M.D., as an Authorized User (AU) for the oral administration of sodium iodide I-131 in quantities greater than 33 millicuries.** Please note that the major changes made to your license are printed in **bold** font. Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U. S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

The submitted information indicates that Dr. Stockmann has completed at least 3 AU-supervised cases, involving the administration of greater than 33 millicuries of sodium iodide I-131, as required under 10 CFR 35.394(c)(2)(vi). However, as we discussed by telephone, additional documentation is required to verify the qualifications of the supervising AUs. If you wish to expand Dr. Stockmann's authorizations at a later date, please resubmit your request. Include a completed NRC Form 313A (AUT), including documentation that any supervising individuals have the appropriate AU qualifications.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

Note that the NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture. We strongly encourage you to review this material and adapt it to your particular needs in order to develop and maintain a positive safety culture as you engage in NRC-regulated activities.


