SUMMARY

By application dated May 4, 2012, the Department of Energy, Division of Naval Reactors, requested renewal of Certificate of Compliance No. 9792, for the Model No. Model 1 D1G Core Basket-Thermal Shield Shipping and Storage Container package. The certificate has been renewed for a five year term that expires on January 31, 2018.

EVALUATION

By application dated May 4, 2012, Naval Reactors requested renewal of Certificate of Compliance No. 9792, for the Model No. Model 1 D1G Core Basket-Thermal Shield Shipping and Storage Container package. Naval Reactors stated that there has been no operational experience or container modification that would preclude continued use of these containers. In addition, Naval Reactors requested simplification of the shipping restriction regarding average daily temperature. This is because the remaining containers that require shipping all require an average daily temperature above +10°F. Thus, the restrictions where the average daily temperatures are above +30°F and +40°F have been removed. The staff reviewed the documents referenced in the certificate and determined that the documentation was available and complete.

CONDITIONS

The following changes have been made to the certificate of compliance:

Condition No. 6(b) has been updated to simplify the average daily temperature shipping restriction.

Condition No. 9 has been updated to reflect an expiration date of January 31, 2018.

The References section has been updated to include this renewal request.

CONCLUSION

The certificate has been renewed for a five year term that expires on January 31, 2018. This change does not affect the ability of the package to meet the requirements of 10 CFR Part 71.
