Dear Mr. Minish:

This is in reference to your letter dated May 25, 2012 requesting an amendment to Nuclear Regulatory Commission License No. 50-29439-01. In order to continue our review, we need the following additional information:

1. You have requested to add a Seaman-200 portable gauge to your license containing Cs-137 and Am-241. However, it is my understanding that the unit owned by City of Valdez, Alaska contains Radium-226. Please confirm that the isotope you wish to add to your license is Radium-226 with a maximum possession limit of 5.5 millicuries.
