Michael or Robert,

Do you know where Detroit Edison ("DE" in the comment below) ships its mixed waste? This is a question in one of the public comments on our Draft EIS for Fermi 3. Yesterday I called Randy Westmoreland of DTE, who referred me to Barry Muller (734-586-1576), who hasn't returned my call. We need to finalize these comments a.s.a.p., so can you please help me answer this question? My red highlighted response below is a guess from looking in the 2010 Fermi 2 Radioactive Effluent Release Report.

Comment: "DE stated that the mixed waste that cannot be treated onsite will be temporarily stored at a remote monitored structure until it is shipped for offsite disposal at an approved facility." (v 1, p 5.120) Where is DE now shipping Fermi 2's mixed waste? (0016-4-13 [Collins, Jessie])

Response: *As stated in Chapter 5 of the EIS, Fermi 2 operates under a State of Michigan low-level mixed waste exemption that allows long-term temporary storage of unlimited quantities of mixed waste. Detroit Edison has been shipping mixed waste from Fermi 2 to EnergySolutions in Oak Ridge, TN, but may use any other approved, licensed facility. No changes were made to the EIS as a result of this comment.*
