SUBJECT: REVISED SCHEDULE AND PLANS FOR JAPAN LESSONS-
LEARNED

The purpose of this memorandum is to request approval for revisions to proposed Tier 1 and Tier 2 Japan lessons-learned action items. Specifically, the staff proposes to: (1) subsume the Tier 2 orders on emergency preparedness (EP) within an advance notice of proposed rulemaking (ANPR); and (2) extend the due date for delivery of a Tier 1 notation vote paper on evaluation of boiling water reactor containment vent operability under severe accident conditions to November 2012. The Tier 1 notation vote paper will include a discussion on the considerations for requiring filters.

Tier 2 Emergency Preparedness Orders

In SECY-11-0137, "Prioritization of Recommended Actions to Be Taken in Response to Fukushima Lessons Learned," the staff prioritized the issuance of EP orders associated with Recommendation 9.3 as a Tier 2 action. At that time, the staff recommended engaging stakeholders on acceptance criteria, and developing and issuing an order to ensure that licensees can adequately respond to prolonged station blackout (SBO) and multiunit events. The specific actions were to include: (1) adding guidance to emergency plans for performing multi-unit dose assessments; (2) conducting periodic training and exercises for multi-unit and prolonged SBO scenarios; and (3) ensuring that EP equipment and facilities are sufficient to deal with multi-unit and prolonged SBO scenarios. However, in accordance with the additional work performed and stakeholder input received on this topic, the staff now proposes to include these Tier 2 activities with the EP-related Tier 3 activities in a single ANPR. The staff recommends that it will be more effective and efficient to utilize the ANPR process. An ANPR is an appropriate regulatory action because: (1) continued plant operation and licensing activities do not pose an imminent risk to the public and are not inimical to the common defense and security; (2) recent revisions to the EP regulations and the proposed enhancements to licensee
