SYNOPSIS

This investigation was initiated by the U.S. Nuclear Regulatory Commission (NRC), Office of Investigations (OI), Region II (RII), on August 10, 2011, to determine whether a contracted foreman employed by Williams Specialty Services, and working at the Turkey Point Nuclear Plant (TPNP) was discriminated against as a result of raising safety concerns.

Based upon the evidence developed during the investigation, OI:RII did not substantiate that a contracted foreman employed by Williams Specialty Services, and working at the TPNP, was discriminated against as a result of raising safety concerns.
