

The purpose of this modification is:

(1) to increase the Program Manager labor category hours for the base year from 180 hours to 960 hours, thereby increasing the current ceiling from \$241,248.98 to \$358,209.12; and (2) to provide incremental funding in the amount of \$281,209.12, thereby increasing the obligation amount from \$77,000.00 to \$358,209.12.

Accordingly, the following changes are hereby made:

**1. Section B.2 – CONSIDERATION AND OBLIGATION – COST REIMBURSEMENT—NO FEE (AUG 2011) ALTERNATE I (AUG 2011)**, is deleted in its entirety and replaced with the following in lieu thereof:

(a) The total estimated cost to the Government for full performance under this contract is **\$2,437,358.31**.

(b) The amount presently obligated by the Government with respect to this contract is **\$358,209.12**. The Contracting Officer may issue orders for work up to the amount presently

(c) It is estimated that the amount currently obligated will cover performance through September 30, 2012.

(d) This is an incrementally-funded contract and FAR 52.232-22 "Limitation of Funds" applies.
