Steve and Ngola,

Luminant hereby requests and extension to respond to RAI-256 (6456) regarding an integrated cooldown test of the RHRS, ESWS and CCWS and capacity testing of the peak heat loads for the UHS from the CCWS, ECWS and ESW pump. Luminant is still assessing the options regarding the performance of these tests. It appears that there is insufficient heat load to do capacity testing prior to plant startup. We are continuing to investigate what testing can be done prior to startup and what testing cannot be performed until after startup. We are communicating with cooling tower experts to enhance our assessment of the available options.

Luminant requests approximately a 7 week delay and a new due date of July 20, 2012.
