Dear Administrative Judges:

Pursuant to 10 C.F.R. §§ 2.1203 and 2.336 and as modified by the Atomic Safety and Licensing Board's ("Board") Memorandum and Order dated June 15, 2011 ("Order"), the staff of the Nuclear Regulatory Commission ("Staff") is providing an index identifying documents subject to disclosure under the Board's Order. On or about July 9, 2012, materials in the hearing file may be accessed through the Agencywide Documents Access and Management System ("ADAMS") and through the Electronic Hearing Docket ("EHD"). The index contains the ADAMS accession number, document date, and the document title.

As previously noted, the Staff is currently unable to project dates for the publication of the Draft Supplemental Environmental Impact Statement (“DSEIS”) and the Final SEIS at this time.
