Dear Ms. Saverio,

This is in reference to your letter dated June 5, 2012 to Mr. Lynch and the NRC Regional Administrator. I wanted to state that I am working with Mr. William Lynch of Safety Light Corporation to get the remainder of the funds held by the Trust Agreement dated December 12, 1994. I talked with Mr. Lynch today. He plans to send me a letter to spend the remaining funds authorized for activities in accordance with the Trust Agreement by the end of next week. This request should expend all of the funds in the trust agreement. I will need to get a letter signed by the Regional Administrator which will take some time to perform. Once that is completed the trust can be terminated. I am requesting for an extension to your notice of resignation as I believe that we should be able to terminate this trust agreement quicker than obtaining another trust agreement.
