Pursuant to the Freedom of Information Act, 5 U.S.C. § 552, I request access to and copies of any documents detailing:

- The sale price of a 1966 sale of 8700 tons of barium sulfate containing seven tons of uranium from the Atomic Energy Commission to the Commercial Discount Corporation of Chicago
- The sale price of 8700 tons of barium sulfate containing seven tons of uranium from the Commercial Discount Corporation of Chicago to the Cotter Corporation of Colorado.
- The sale price of 1966 sale of 74,000 tons of Belgian Congo pitchblende raffinate by the AEC to the Commercial Discount Corporation of Chicago.
- The sale price of a 1966 sale of 32,500 tons of Colorado raffinate by the AEC to the Commercial Discount Corporation of Chicago.
- The chemical compositions of the any of the materials mentioned above that were sold to the Commercial Discount Corporation of Chicago by the AEC.
- A 1976 investigation by Region 3 of the NRC regarding West Lake Landfill in St. Louis, MO
- FOIA requests submitted within the last five years relating to the West Lake Landfill Superfund or the documents requested above.
