Dear Ms. Landrum:

On behalf of the U.S. Nuclear Regulatory Commission (NRC), I am responding to your May 8, 2012, letter to the Freedom of Information Act/Privacy Act Officer, in which you appealed the agency's April 25, 2012, response regarding your April 20, 2012, Freedom of Information Act (FOIA) request (FOIA/PA-2012-0203) for information regarding the MLTS status of Chemical Service Lab.

Acting on your appeal, the NRC's Office of Federal and State Materials and Environmental Management Programs conducted another thorough search of the MLTS database and has confirmed again that the information you requested is not included in the MLTS database. Therefore, your appeal for adequacy of search is denied.

This is NRC's final decision. As set forth in the FOIA (5 U.S.C. § 552 (a)(4)(B)), judicial review of this decision is available in a district court of the United States in the district in which you reside or have your principle place of business. Judicial review can also take place in the district in which the agency's records are located or in the District of Columbia.

However, based on the additional information which you provided, the NRC staff located records for Chemical Service Lab license 13-16501-02. The enclosed records identified on Appendix A are being released in their entirety, and the Appendix B record is being withheld in part under Exemption 4 [Title 10 of the *Code of Federal Regulations* 2.390 (a)(4)], due to the proprietary nature of the information. This determination may be appealed within 30 days by writing to the FOIA/PA Officer, U. S. Nuclear Regulatory Commission, Washington, DC 20555-0001. Clearly state that it is a FOIA/PA Appeal on the envelope.
