Dear Dr. Zhang:

Enclosed is Amendment No. 108 to your NRC Material License No. 13-01284-02 in accordance with your request. Please note that the major changes made to your license are printed in **bold** font.

Please review the enclosed document carefully and be sure that you understand all conditions. In correspondence dated March 12, 2012, and June 12, 2012, you indicated that you wished to release for unrestricted use certain areas located at 2200 Randallia Drive; 11115 Parkview Plaza Drive, and the location of use at 1819 Carew, all in Fort Wayne, Indiana.

The NRC staff has reviewed your final status surveys. Based on its review, the staff has concluded that all licensable radioactive material has been removed from the areas of use specified at the addresses above and your former location of use noted above and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Based on these conclusions no further remediation or actions with respect to NRC regulated material is required for these areas of use and the former location of use and they are suitable for unrestricted use.

At this time I also adjusted the authorization in Subitem No. 7.D. so that the detailed authorizations appear in Subitem No. 9.D. This modification should enhance your license.

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system. Pursuant to NRC's RIS 2005-31 and in accordance with 10 CFR

Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.
