Dear FOIA Officer:

Pursuant to the Freedom of information Act, 5 U.S.C. sub section 552 or equivalent state law, we request the opportunity to review all documents in the possession of the U.S. Nuclear Regulatory Commission. This request includes, but is not limited to, any and all documents that refer or relate to the following:

- 1) Any violation of law, regulation, code, ordinance or statute, between 1969 and 1989, related to radioactive material at E.R. Squibb & Sons/Bristol-Myers Squibb facility located in New Brunswick, N.J., 08909 (referred to hereafter as "Squibb");
- 2) Any inspection of the Radiopharmaceutical Operations and/or Medotope facility at Squibb between 1969 and 1989;
- 3) All Radiological Contingency Plans for the Radiopharmaceutical Operations and/or Medotope facility at Squibb in effect from 1969 to 1989;
- 4) Any testing or monitoring of radioactive levels at any part of the Squibb facility between 1969 and 1989;
- 5) Any spill, discharge, release, escape, dispersal, migration of radioactive mater at any part of the Squibb facility between 1969 and 1989;
- 6) Any emergency, incident, accident, evacuation, unusual event or alert at any part of the Squibb facility related to radioactive material between 1969 and 1989;
- 7) Any monitoring of Squibb personnel, between 1969 and 1989, for exposure to radioactive material;


- 8) Any protective clothing provided to Squibb personnel in the Radiopharmaceutical Operations and/or Medotope facility at Squibb between 1969 and 1989;
- 9) Any exposure to radioactive material by personnel at Squibb, between 1969 and 1989, that exceeds the ANSI standard of 25 mrem/yr;
- 10) Sickness of Squibb personnel potentially related to exposure to radioactive material; and
- 11) Harry J. Bartlett, an employee of Squibb.

As provided under the FOIA, we expect to receive a reply within twenty (20) working days. In the event that a determination is made that some or all of the documents requested are exempt from disclosure under the FOIA, please identify those documents withheld and the basis for the departments' exemption in each instance. Additionally, if for any reason the requested information is not in your possession, please so advise and indicate, if possible, where such information can be obtained. We are requesting that any responsive documents be compiled at our expense not to exceed \$500. If documents exceed \$500, we suggest an index be created so that we may highlight and identify which documents we are interested in reproducing.
