

20.0 Question and Response Guide

In large part, the language in Tier 2 is taken directly from the Standard Safety Analysis Report (SSAR) for the ABWR. In numerous places throughout the SSAR, the SSAR refers to itself. In preparing the DCD, each reference to the SSAR was converted to Tier 2 of the DCD except for Chapter 20. For Chapter 20 it was deemed impracticable to attempt this conversion. As a result, references to the SSAR have been retained in Tier 2 Chapter 20. Each Tier 2 reference to the SSAR in this chapter shall be interpreted as a reference to Tier 2 of the DCD.

This chapter includes historical responses by GE Nuclear Energy to each NRC request for additional information (RAI) during its review of the ABWR Standard Plant. Updated information and requirements applicable to COL applicants is provided as appropriate in other chapters of the DCD.

20.1 Question Index

This subsection provides an index to each NRC request for additional information (RAI) during its review of the ABWR Standard Plant. Each NRC question is designated with the NRC branch questions ID number (see Table 20.1-1) followed by the number of the question of the review area for that branch.

For example, question number 210.2 designates the second question of the Civil Engineering and Geoscience Branch (ECGB). The index below provides an up-to-date listing in numerical order of each question.
