The purpose of this conference call was for the licensee to have additional discussions with the NRC staff prior to submitting a license amendment request (LAR) to transition to NFPA 805. The topic covered in the licensee's presentation included; the use of probabilistic risk assessment sensitivities, installation of incipient fire detection systems in main control room and cable spreading room, and the treatment of solid bottom cable trays. No decision of the technical adequacy of the licensee's efforts was made by the staff during this conference call.
