Please find enclosed NRC Form 327, "SPECIAL NUCLEAR MATERIAL (SNM) PHYSICAL INVENTORY SUMMARY REPORT," for the Material Balance Period (MBP) ending May 4, 2012 at the Columbia Fuel Fabrication Facility (CFFF), Westinghouse Electric Company LLC.

The Limit of Error of Inventory Difference (LEID), Active Inventory, Throughput and associated limits for the Low-Enriched Uranium (LEU) report have been calculated for the 2012 MBP based on our current data. Westinghouse is currently working with Nuclear Materials Management and Safeguards System (NMMSS) staff to reconcile our reports and is aware of at least one issue which is anticipated to result in a change to the Inventory Difference. If upon reconciling with NMMSS a revision to the Form 327 is warranted that revision will be transmitted promptly to your attention.

Westinghouse requests that the enclosure to this letter be withheld from public disclosure in accordance with 10 CFR 2.390(d).
