Dear Sir:

As required by Reference 2 above, Nuclear Fuel Services, Inc (NFS) agreed to develop and implement an appropriate safety culture improvement plan to address the findings identified in the second Safety Culture Assessment report that was provided to the NRC on June 29, 2010. NFS also agreed to assess the effectiveness of its plan, and implement additional corrective actions for any weaknesses or deficiencies identified, by June 2012.

The plan was completed and submitted to the NRC on March 23, 2011 (Reference 3). The plan also references an Action Listing which is maintained at the NFS site to assist in managing the actions. In February 2012, an internal Safety Culture Assessment Panel was formed to assess the effectiveness of the plan and to recommend any additional corrective actions for weaknesses or deficiencies identified. The Panel's assessment is complete, and their report is available for review at the NFS site.
