SUBJECT: SUMMARY OF PUBLIC MEETING "INFORM THE PUBLIC AND
SOLICIT COMMENTS ON THE NRC'S DRAFT NUREG-2122"

On June 19, 2012, the Nuclear Regulatory Commission (NRC) staff and various consultants from Sandia National Laboratories (SNL) and Brookhaven National Laboratory (BNL) met with the members of public at the Church Street Building to discuss the draft NUREG-2122 report titled "Glossary of Risk-Related Terms in Support of Risk-Informed Decisionmaking." The participants from members of public included representatives from Areva, Bechtel Corporation, Curtiss-Wright Flow Control Solutions Company/Scientech, Electric Power Research Institute (EPRI) and Nuclear Energy Institute (NEI). The purpose of the meeting was to inform the public and solicit comments on the NRC's draft NUREG- 2122, "Glossary of Risk Related Terms in Support of Risk-Informed Decision Making." In the opening remarks, Deputy Director, Doug Coe recognized and praised the efforts of those involved in the development of the NUREG-2122. He also emphasized the importance of risk communicate and encouraged the public to provide comments, in order to improve the content of the NUREG report with consistent definitions of the risk-related terms.

The staff presentation covered an introduction of the project, the method of selecting and defining terms, the glossary structure and the path forward. Some of the terms were illustrated during the meeting for a high-level discussion. The NRC will continue to hold meetings or teleconferences with industry and the public to continue to promote open communication on the development of the final revision of the NUREG.
