Dear Dr. Gray:

Enclosed is your NRC Material License No. 21-03298-06 in accordance with your request.

Please note that this license is being issued without approved decommissioning financial assurance (DFA). We have received and are in the process of reviewing your Decommissioning Funding Plan Cost Estimate dated April 29, 2012, which provided an estimate of the cost to decommission activities under this license at 782,420 dollars.

However, we have not received the financial assurance instrument for the 782,420 dollars. This was communicated to Dr. Thomas Mangner of your staff on June 26, 2012, and based on that telephone call it is our understanding that you are in the process of securing an instrument, and that once the documents are finalized they will be forwarded to us for review.

Therefore, as a result of the pending receipt and approval of DFA for this license, we have added license condition number 19 which requires that Detroit Medical Center (DMC) provide acceptable DFA as required by 10 CFR Part 30, Section 30.35. The condition also requires that DMC submit DFA progress reports to the U.S. Nuclear Regulatory Commission, Region III, Attention: Chief, Nuclear Materials Licensing Branch, 2443 Warrenville Road, Suite 210, Lisle, Illinois 60532 to update the NRC on the status of securing DFA, and submit those reports every 30 days until such time that DFA is submitted to the NRC for review. If the NRC determines that the DFA is not acceptable, DMC will need to continue to submit DFA progress reports every 30 days until acceptable DFA is provided to the NRC.

Also please note that based on the June 26 telephone call between Dr. Mangner and me, we have not added the sealed calibration sources to your license at this time. Our policy requires that we specifically identify sealed sources on all licenses by either make and model number of the source in item 7 of the license, or the make and model number of the device in item 9. Dr. Mangner indicated that at this time the hospital does not possess these sources, and he was not able to identify specific sources to be listed on the license at this time.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Please be advised that your license expires at the end of the day, in the month, and year stated in the license. Unless your license has been terminated, you must conduct your program


involving byproduct materials in accordance with the conditions of your NRC license, representations made in your license application, and NRC regulations. In particular, note that you must:

1. Operate in accordance with NRC regulations 10 CFR Part 19, "Notices, Instructions and Reports to Workers; Inspections," 10 CFR Part 20, "Standards for Protection Against Radiation," and other applicable regulations.
2. Notify NRC, in writing, within 30 days:
 - a. When the Radiation Safety Officer permanently discontinues performance of duties under the license or has a name change; or
 - b. When the mailing address listed on the license changes.
3. In accordance with 10 CFR 30.36(d) and/or license condition, notify NRC, promptly, in writing, and request termination of the license:
 - a. When you decide to terminate all activities involving materials authorized under the license; or
 - b. If you decide not to complete the facility, acquire equipment, or possess and use authorized material.
4. Request and obtain a license amendment before you:
 - a. Order byproduct material in excess of the amount, or radionuclide, or form different than authorized on the license;
 - b. Add or change the areas of use or address or addresses of use identified in the license application or on the license; or
 - c. Change ownership of your organization.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
