**GE-HITACHI GLOBAL LASER ENRICHMENT’S CORRECTED  
PREFILED TESTIMONY ON TOPIC 4**

GE-Hitachi Global Laser Enrichment LLC (GLE) is submitting corrected prefiled testimony on Topic 4 (marked as Exhibit GLE-021), which GLE initially filed on June 22, 2012. GLE has made two corrections to the Topic 4 prefiled testimony. First, GLE has deleted the last sentence on page 12 (“A pictorial representation of this process is provided below.”). Second, GLE has deleted the pictorial representation from page 13 of GLE’s prefiled testimony. These are the only two changes made to GLE’s prefiled testimony on Topic 4.
