Gentlemen:

On March 12, 2012, the Nuclear Regulatory Commission (NRC) issued Reference 1 to Wolf Creek Nuclear Operating Corporation (WCNOC). Enclosure 3 of Reference 1 contains specific Requested Actions, Requested Information, and Required Responses associated with Recommendation 2.3 for Seismic. This letter provides WCNOC's 120-day response to Reference 1 for Seismic Recommendation 2.3 for Wolf Creek Generating Station (WCGS).

For seismic Recommendation 2.3 (walkdowns), Enclosure 3 of Reference 1 states that each licensee will confirm that they intend to use the NRC-endorsed seismic walkdown procedure, or provide to the NRC a description of the process that will be used to conduct the walkdowns and to develop the needed information.



WCNOC confirms that it will use seismic walkdown guidance (EPRI 1025286, "Seismic Walkdown Guidance: For Resolution of Fukushima Near-Term Task Force Recommendation 2.3: Seismic") as endorsed by Reference 2 to conduct the walkdowns and develop the needed information at WCGS.
