This letter is to notify that our site office performing services at Site IR-3 at the Hunters Point  
Naval Shipyard has been demobilized. Onsite radiological activities ceased in May and project  
site activities ceased in June, 2012.

Radioactive waste was transferred to the Navy's on site contractor (TPMS-Energy Solutions, TES)  
for disposal. TES provides brokerage services inclusive of the offsite transport and disposal of  
project generated radioactive waste and the staging of Department of Transportation (DOT)  
approved waste storage and transportation containers. The control of radioactive waste package  
activities and site locations designated for "post loading" LLRW container operations are subject  
to requirements in the TES NRC Materials License No. 37-31379-02.

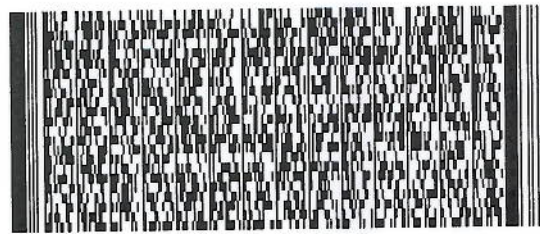

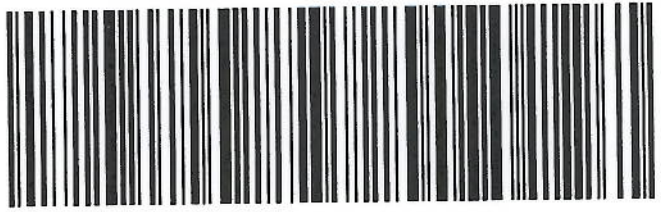
