**APPROVAL TO SHIP CH2M HILL B&W WEST VALLEY, LLC (CHBWV) LOW-LEVEL RADIOACTIVE WASTE TO THE NEVADA NATIONAL SECURITY SITE (NNS)**

CHBWV has completed the waste profile approval process described in the Nevada National Security Site Waste Acceptance Criteria (NNSWAC), Revision 8-01. The National Nuclear Security Administration/Nevada Site Office (NNSA/NSO) reviewed and commented on the following waste profiles:

NNSA/NSO approves the shipment and disposal of the above listed waste streams under the requirements of the NNSWAC, Revision 8-01, and the CHBWV Waste Certification Program. The enclosure lists the current CHBWV approvals and supersedes all previous approval memoranda.

**Conditional Approval for WVDP-000000007:** Waste from WVDP-000000007 will be accepted only if it is determined to be waste incidental to reprocessing (WIR) in accordance with DOE Order 435.1. WVES must notify NNS Operations at least 90 days prior to shipment.

Prior to initiating shipment of these waste streams, please notify National Security Technologies, LLC (NSTec) Disposal Operations personnel at (702) 295-6811 with a planned shipping date. NSTec will ensure sufficient disposal capacity is available and provide the necessary equipment and personnel for disposal activities.
