The purpose of this modification is to provide incremental funding in the amount of \$154,000.00 thereby increasing the total obligations from \$319,000 to \$473,000. Accordingly the first sentence of paragraph (b) of section A.2, entitled "CONSIDERATION AND OBLIGATION - LABOR HOUR" paragraph (b) first sentence is deleted in its entirety and replaced with the following:  
"The amount obligated by the Government with respect to this contract is \$473,000.00."
