PURPOSE: The purpose of the meeting between FirstEnergy Nuclear Operating Company (FENOC, the licensee), and the U.S. Nuclear Regulatory Commission (NRC) staff is to discuss a future license amendment request (LAR) involving a transition to NFPA 805, for Beaver Valley Power Station, Units 1 and 2. Specifically, the licensee has notified the NRC staff that current projections indicate that the previously committed due date of September 30, 2012, for the NFPA 805 LAR, will not be met. The meeting will provide the licensee an opportunity to explain this projection.
