SUBJECT: SUMMARY OF JUNE 19, 2012, MEETING WITH TOSHIBA
CORPORATION REGARDING THE ACCEPTANCE REVIEW STATUS
AND PATH FORWARD OF THE TOPICAL REPORT FOR TOSHIBA
FPGA-BASED SAFETY RELATED INSTRUMENTATION AND
CONTROL SYSTEMS, REVISION 0

On June 19, 2012, a closed meeting was held between the U.S. Nuclear Regulatory Commission (NRC) staff and representatives of Toshiba Corporation (Toshiba). The purpose of the meeting was to candidly discuss the potential issues the NRC staff found that could affect the acceptance of the Topical Report (TR) for Toshiba FPGA-based safety related instrumentation and control systems, Revision 0, and to discuss the path forward options.

The NRC staff provided detailed explanations for the following issues of concern to the Toshiba representatives:

- Referencing unapproved TRs
- Proprietary markings
- Definition of product scope
- Sufficiency of information

The NRC staff provided detailed explanations for the following path forward options:

- Withdraw and resubmit the TR
- Non-acceptance with an opportunity to supplement
- Non-acceptance without an opportunity to supplement

Following lengthy discussions, the Toshiba representatives indicated that all the issues and the options were clearly understood. The Toshiba representatives stated that a formal letter would be submitted to the NRC indicating the selected option.
