Dear Mr. Davis:

On August 20, 2012, the U.S. Nuclear Regulatory Commission (NRC) will begin a supplemental inspection at the Fermi Power Plant. This on-site inspection is scheduled to be performed August 20 through 24, 2012.

In order to minimize the impact to your on-site resources and to ensure a productive inspection for both sides, we have enclosed a request for documents needed for this inspection. The documents identified are those the inspector will need prior to arrival at the site. It is important that all of these documents are up-to-date and complete in order to minimize the number of additional documents requested during the on-site portion of the inspection.

We have discussed the schedule for these inspection activities with your security manager, Mr. Herb Torberg, and understand that our regulatory contact for this inspection will be Mr. Rodney Johnson of your organization.
