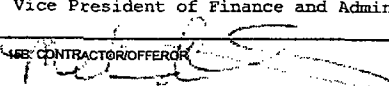
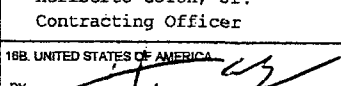

System SecCat upgrade from low to "moderate;" b). "Continuous" system monitoring, management, and mitigation; c). Additional physical security controls & processes; d). Revise skill mix to implement & support MOM CE technology; and e). Establish new processes and procedures for the current MOM CE.
