The State of North Carolina welcomes the opportunity to comment on the petition by Mr. Michael Mariette to amend 10 CFR 50.47(c)(2) and 10 CFR 50.47(b)(14), Appendix E. Following a review of the petition documentation and the Nuclear Energy Institute (NEI) technical response by the North Carolina Division of Emergency Management (NCEM) Technical staff, the State of North Carolina does not support the petitioner's conclusions/request and fully support the NEI position paper submitted to the NRC recommending denial of the Petition. NCEM is responsible for coordinating state-wide emergency response to natural and technological events that threaten public health and safety.

Specifically, the Petition should be denied because:

- (1) Existing NRC Emergency Planning Zones (EPZs) are based on a conservative analysis of a wide range of severe accident consequences and continues to provide assurance that adequate protective measures can and will be taken in the event of an emergency.
- (2) Existing EPZs are large enough to facilitate protective actions, and provide plans and procedures for zone expansion if necessary.
- (3) The Petition has provided no new information that refutes the current planning basis or warrants a change to the size of the existing Emergency Planning Zones.

The State of North Carolina has experienced a 37 year history of successful nuclear power generation by the four nuclear power facilities—Brunswick Nuclear Power Plant and Harris Nuclear Plant owned and operated by Progress Energy; McGuire Nuclear Power Station and Catawba Nuclear Power Station owned and operated by Duke Energy. As commendable as that history is, we fully appreciate the public's concern and perception regarding life safety issues.

We work diligently on a continuing basis to ensure that appropriate response systems are put in place and may be implemented should there ever be a threat to public health and safety of the citizens of this State. In that regard, the emergency response agencies of the State of North Carolina will continue to support
