ORDER

(Concerning Evidence Admitted During the Proceeding)

On July 11-12, 2012, the Board conducted an evidentiary hearing in the Atomic Safety Licensing Board Hearing Room in Rockville, MD. Because a transcript may not be publicly available for some time due to the classified nature of much of the material discussed, this Order will summarize the Board's rulings at the hearing concerning the admission of evidence:

- 1) GLE007 is not admitted.¹ All other GLE exhibits (GLE001 through GLE006 and GLE008 through GLE024) are admitted, including all relevant subparts. GLE exhibits containing subparts have been renumbered to indicate subparts exist, and GLE021 has been notated with an "R" to indicate the revised version was admitted.
- 2) All NRC Staff exhibits (NRC001 through NRC124) are admitted, including all relevant subparts. NRC Staff Testimony has been assigned exhibit numbers NRC118 through NRC124. NRC Staff exhibits containing subparts have been renumbered to indicate

subparts exist, and NRC123 has been notated with an "R" to indicate the revised version was admitted.

Additional copies of BRD001 and BRD002 are attached for the convenience of the parties.

After the Board issues its Initial Decision, the exhibits containing ECI or classified information will be submitted by the Board to the Office of the Secretary for the official record. Public voluminous documents have been marked and submitted to the Office of the Secretary for the official record.
