This is in reference to your current financial assurance instrument, an escrow account. The NRC published the new financial assurance rules in the Federal Register Notice dated June 17, 2011 [(Volume 76, No. 117, pages 35512 – 35573) ADAMS Accession No. ML121350224]. The NRC is revising 10 CFR 30.35 which applies to your Nuclear Regulatory Commission License Number 07-16199-01. The rule will be effective on December 17, 2012, and will no longer allow escrow accounts. Please review the Federal Register Notice and provide the NRC with a new financial assurance instrument. Respond before September 1, 2012. We must review, resolve any discrepancies, and approve your new financial assurance instrument before December 17, 2012.
