2) Physical Description

This shipment will consist of 315 drums of Uranium Ore Concentrate (U-308) in 5 x 20' ocean containers. The total weight of the shipment is 68,136.1 kgs of U-308.

3) Transportation and Route Schedule

The vessel sailed from Adelaide on April 25, 2012. The ocean transportation from Adelaide to Seattle, WA USA will be the responsibility of Hapag Lloyd. The vessel will unload at Seattle, WA USA on or about May 18, 2012. The inland transportation from Seattle, WA to Metropolis, IL will be the responsibility of RSB LOGISTIC SERVICES, INC.
