2) Physical Description

This shipment will consist of 120 drums of Uranium Ore Concentrate (U-308) in 2 x 20' ocean containers. The total weight of the shipment is 28,626.2 kgs of U-308.

3) Transportation and Route Schedule

The vessel sailed from Adelaide on April 13, 2012. The ocean transportation from Adelaide to Seattle, WA USA will be the responsibility of Hapag Lloyd. The vessel will unload at Seattle, WA USA on or about May 04, 2012. The inland transportation from Seattle, WA to Blind River, ON will be the responsibility of RSB LOGISTIC SERVICES, INC.
