Dear Mr. Laughlin:

On September 22, 2011, Louisiana Energy Services (LES) transmitted a request add the TC-21 centrifuges to Safety Analysis Report (SAR) Table 5.1-2, "Safety Criteria for Buildings/Systems/Components". To determine if this request should be granted, we considered the SAR supplied with the request, supplementary information provided dated October, 28, 2011, as well as your responses to our requests for additional information dated March 13, 2012. Lastly, we conducted a site visit the week of March 19, 2012, to verify the information provided.

The U.S. Nuclear Regulatory Commission (NRC) staff has completed its review and determined that LES was correct in the assertion that the TC-21 centrifuges did not create a new accident sequence or credible event that would need to be mitigated by the identification of "Items Relied On For Safety." Thus, no changes to the Integrated Safety Analysis were required.

Based on these conclusions, the amendment request is approved, and license SNM-2010 has been modified to reflect this action. We have also attached an SAR, documenting the review as Enclosure 1. Your amended license, SNM-2010 (Amendment 54), is attached as Enclosure 2.

Because the activities of this amendment involve administrative actions, the NRC staff determined that the proposed activities do not individually or cumulatively have a significant effect on the human environment. Therefore, in accordance with Title 10 of the *Code of Federal Regulations* (10 CFR) 51.22(c)(11), neither an Environmental Assessment nor an Environmental Impact Statement is warranted for this action.
