Dear Mr. Vinson:

We have reviewed the proposed and final revisions to the Illinois regulations 32 Ill. Administrative Code Parts 330 and 335, received by our office on June 21, 2012. We also received your July 20, 2012 request to withdraw one of the proposed Part 335 regulations. These regulations were reviewed by comparison to the equivalent Nuclear Regulatory Commission (NRC) rules in 10 CFR Parts 30, 31, 32, 35, 150 and the requirements of the two amendments identified in the enclosed State Regulation Status (SRS) Data Sheet. We discussed our review of the regulations with you on August 3, 2012.

As a result of our review of the proposed and final revisions, we have no comments. We have determined that the regulations, as adopted, meet the compatibility and health and safety categories established in the Office of Federal and State Materials and Environmental Management Programs (FSME) Procedure SA-200.

The SRS Data Sheet summarizes our knowledge of the status of other Illinois regulations, as indicated.
