Indian Point License Amendments Issued

On July 12, 2012, staff issued license amendments approving a newly-designed spent fuel transfer system at Indian Point. Starting in August, spent fuel assemblies will be transferred via a shielded transfer canister in a borated water environment from the Unit 3 to the Unit 2 spent fuel pool (SFP) prior to ultimate storage at the common Indian Point independent spent fuel storage installation (ISFSI). With the Unit 3 SFP virtually full, the licensee is currently unable to perform either a full core offload or the next refueling outage scheduled for March 2013.

Grand Gulf Nuclear Station, Unit No. 1, Extended Power Uprate (EPU)

On July 18, 2012, staff approved an increase in the maximum steady-state power level at Grand Gulf Nuclear Station, Unit No. 1 from 3,898 megawatts thermal (MWt) to 4,408 MWt, which is approximately a 13-percent increase in thermal power over the previous licensed thermal power and a 15-percent total increase over the original licensed thermal power (3,833 MWt). The staff determined that the licensee could safely increase the reactor's output primarily by changing the core design and upgrading certain balance-of-plant components, such as replacing the steam dryer, high-pressure turbine, and reactor feed pump turbine rotor. The power uprate will increase the unit's generating capacity by approximately 200 megawatts electric. The licensee plans to implement the EPU over the next few months.
