**Background:** UniStar's earlier letter with ADAMS Accession Number ML12166A289, dated June 13, 2012, provided a response date of April 15, 2013, for responding to Questions 03.07.02-70 through 03.07.02-74 of your RAI Number 343 (eRAI 6471). Based on my discussions with the technical branch, this response schedule would have an adverse effect on the schedule for completion of the SER with no open items.

UniStar was advised of the adverse impact on schedule and they were asked to reconsider the response issue date. Based on my renegotiation, UniStar was able to improve the response date for these five questions to January 31, 2013.
