SUBJECT: SAFETY LIGHT CORPORATION, CONSENT TO THE WITHDRAWAL AND
TERMINATION OF DECOMMISSIONING TRUST FUND AT JPMORGAN
CHASE BANK, N.A., CONTROL NOS. 577740 AND 577741

Dear Ms. DeMarco:

This refers to the letter dated July 10, 2012, from William E. Lynch, Jr., Vice President of Safety Light Corporation, requesting written consent to withdraw the remaining funds from the NRC-controlled decommissioning trust fund currently held with JPMorgan Chase Bank. This also refers to your letter dated June 5, 2012, notifying the NRC of your intent to resign as trustee for the Safety Light Corporation trust fund. We understand from Mr. Lynch's letter that these funds are needed to complete the payment for repairing the perimeter fence, and to demolish and remove a house located adjacent to the property. These expenditures are necessary and appropriate to protect the public health and safety, and fall within the provisions of Section 2 of the decommissioning trust fund. The cost of these activities exceeds the remaining monies in the trust fund. Accordingly, we are authorizing Mr. Lynch to withdraw the remaining funds contained in this decommissioning trust fund. We further authorize the termination of this decommissioning trust as contained in Section 15 of the trust fund.
