The purpose of this modification is to:

1. Exercise the Government's unilateral right to exercise an option in accordance with the contracts clause FAR 52.217-9, Option to Extend the Term of the Contract. Accordingly, the full contract period of performance is changed to read:

"March 16, 2012 – September 25, 2013"

The Government hereby exercises Option No. 1 at the rates priced in Section B of the contract.

2. Increase the task order ceiling by \$72,860.15, from \$68,158.42 to \$141,018.57. Accordingly, paragraph (a) under section B.4 Consideration and Obligation-Time and Materials Contract (August 2011) is revised to read as follows:

"(a) Currently, the ceiling price to the Government for full performance under this contract is \$141,018.57."

3. Obligate funds in the amount of \$16,000.00, thereby increasing the total obligated amount from \$16,000.00 to \$32,000.00. Accordingly, paragraph (c), under B.4 Consideration and Obligation-Time and Materials Contract (August 2011) is revised to read as follows:

"(c) The amount presently obligated by the Government with respect to this contract is \$32,000.00."
