## MATERIALS LICENSE

Pursuant to the Atomic Energy Act of 1954, as amended, the Energy Reorganization Act of 1974 (Public Law 93-438), and Title 10, Code of Federal Regulations, Chapter I, Parts 30, 31, 32, 33, 34, 35, 36, 39, 40, and 70, and in reliance on statements and representations heretofore made by the licensee, a license is hereby issued authorizing the licensee to receive, acquire, possess, and transfer byproduct, source, and special nuclear material designated below; to use such material for the purpose(s) and at the place(s) designated below; to deliver or transfer such material to persons authorized to receive it in accordance with the regulations of the applicable Part(s). This license shall be deemed to contain the conditions specified in Section 183 of the Atomic Energy Act of 1954, as amended, and is subject to all applicable rules, regulations, and orders of the Nuclear Regulatory Commission now or hereafter in effect and to any conditions specified below.

## 9. Authorized use:

- A. through C. Research and development as defined in 10 CFR 30.4; fabrication, modification, testing of components, parts and/or devices; laboratory analysis and measurement studies; calibration of the licensee's instruments; munitions testing; and processing and handling of waste from other Department of the Army tenants located at Aberdeen Proving Ground and Adelphi Laboratory Center.

## CONDITIONS

10. Licensed material may be used or stored at the licensee's facilities located at Aberdeen Proving Ground, Maryland or Adelphi Laboratory Center, 2800 Powder Mill Road, Adelphi, Maryland, and at temporary job sites of the licensee anywhere in the United States.
11. A. Licensed material shall only be used by, or under the supervision of, individuals designated, in writing, by the Radiation Safety Committee. The licensee shall maintain records of individuals designated as users for 3 years following the last use of licensed material by the individual.
- B. The Radiation Safety Officer for this license is Patrick Marine.
