SUBJECT: ENDORSEMENT OF NUCLEAR ENERGY INSTITUTE GUIDANCE FOR
DEVELOPING SEISMIC HAZARD INFORMATION REQUESTED IN THE 50.54(F)
LETTER DATED MARCH 12, 2012

Dear Mr. Heymer:

On behalf of the U.S. Nuclear Regulatory Commission (NRC), I am responding to the Nuclear Energy Institute's (NEI's) letter of July 26, 2012, "Approach for Developing Seismic Hazard Information requested in 50.54(f) Letter Dated March 12, 2012,"(hereafter, NEI guidance document). This NEI guidance document can be viewed in the Agencywide Documents Access and Management System (ADAMS) at Accession No. ML12209A066. On March 12, 2011, as part of its response to the accident at the Fukushima Dai-ichi nuclear power plant caused by the March 11, 2011, Tohoku earthquake and subsequent tsunami, the NRC issued requests for information to all operating power reactor licensees and holders of construction permits in the United States to perform a reevaluation of each facility's seismic hazard. The reevaluation will provide the NRC with the information necessary to determine whether additional regulatory actions are required.

The information request asked each licensee or construction permit holder to develop a ground motion response spectrum (GMRS) for its site for comparison with the existing seismic design basis for the plant. For plants where the GMRS exceeds the existing seismic design basis, the licensee has been requested to perform a further risk evaluation to determine the effect of the higher seismic hazard on the plant. The GMRS is developed by combining seismic source models, seismic ground motion models, and incorporating the effects of the local site geology. At public meetings on June 14 and July 24, 2012, the NRC met with NEI and other industry representatives to discuss two issues with regard to incorporating the effects of the local site geology into the development of the GMRS. These two issues are the methodology to be used to develop the local site response and the control point elevation beneath the site at which the GMRS is to be developed. NEI has developed generically applicable guidance that licensees or construction permit holders would be able to use in the performance of their seismic hazard reevaluation, including the incorporation of the local site response. The NRC staff would like to acknowledge that this document was the product of significant interaction between the NRC, NEI, and other stakeholders at public meetings.
