This also refers to the telephone discussions between you and me on June 28, 2012, and July 3, 2012. You requested that the amendment requests to add four authorized users be completed as soon as possible in order to facilitate the delivery of timely patient care. In order to do this, the remaining requests in your letter dated May 24, 2012, will be reviewed within the normal timeframe, approximately less than or equal to 90 days from the date of receipt, June 7, 2012. Your requests for the authorized users have been approved in Amendment No. 133. We will review the remaining requests shortly.
